## ARTICLES OF INCORPORATION OF GLOBAL SALES & TRADING, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

#### ARTICLE I: NAME

The name of the Corporation is GLOBAL SALES & TRADING, INC.

#### ARTICLE II: DURATION

The Corporation shall have perpetual existence.

#### ARTICLE III: PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any or all lawful business for which the corporations may be incorporated under the Florida General Corporation Act.

#### ARTICLE IV: CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of One (\$1.00) Dollar par share.

#### ARTICLE V: SECTION 1244 STOCK
