# ARTICLES OF INCORPORATION OF:

EL ZIPA SEAFOOD RESTAURANT, CORP. 1614 West 68th Street Hialeah Florida 33013

#### ARTICLE I - NAME

The name of this componation is: EL ZIPA SEAFOOD RESTAURANT,

# ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

#### ARTICLE III - PURPOSE
