The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

## ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is: Jane Marie's Fine Antiques and Collectibles, Inc.. The principal office and mailing address is 3948 3rd Street South, Jacksonville Beach, Florida, 32250.

### **ARTICLE 2.0 DURATION**

The duration of the Corporation is perpetual.
