This Corporation shall have one Director initially. The number shall be fixed by the By-Laws and may be changed from time to time.

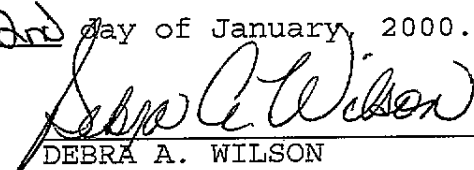

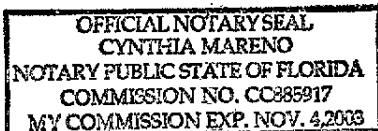

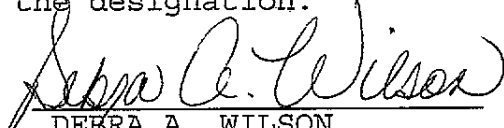
