Name**

The name of the Corporation is Go Long Inc. hereinafter referred to as the "Corporation."

**II.
Purposes**

The private property of the stockholders shall not be subject to the payment of corporate debts.

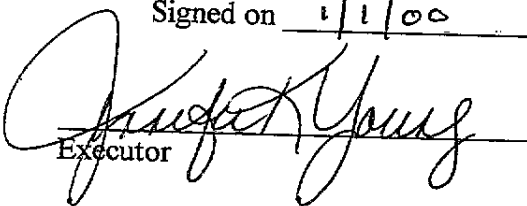
