ARTICLES OF INCORPORATION OF FURNITURE OUTLET, INC.

Article I. Name.

The name of this corporation is **FURNITURE OUTLET**, **INC.** Its address is 106 N. Osceola Avenue, Inverness, FL 34450.

Article II. Purpose.

This corporation is organized for the purpose of transacting any or all lawful business.

Article III. Capital Stock.

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

Article IV. Preemptive Rights.
