## ARTICLES OF INCORPORATION

OF

## ARTICLE I.-- NAME

The name of this corporation is **HOMES ONLINE, INC.**

## ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

## ARTICLE III.- PURPOSE
