The incorporator of this corporation is Jeron Linder and his address is 4012 nw 76th avenue, Coral Springs Fl. 33065.

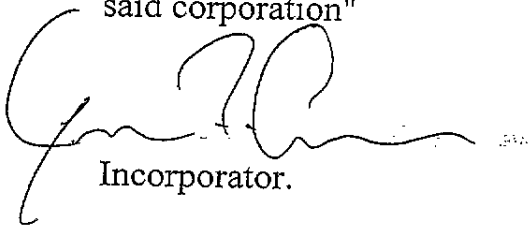
ARTICLE VIII

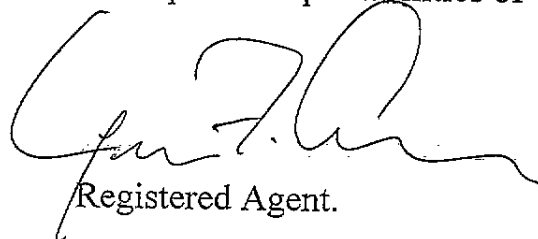
