The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation shall be: STAR ISLAND HAIR BODY AND NAIL , INC..

ARTICLES II.

The principal place of business and mailing address of this corporation shall be 1616 NW 38th Avenue, Lauderhill, Florida 33313.

ARTICLE III.

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated, pursuant to chapter 607, Florida statutes, known as the Florida General Corporation Act.

ARTICLES IV.

The corporation is authorized to issue Ten Thousand (10,000) shares of capital stock of the par value of One Dollar (\$1.00) each.

ARTICLES V.

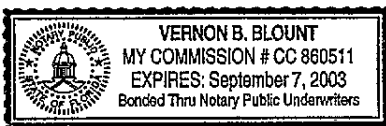
