ARTICLES OF INCORPORATION

OF

WE, the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The corporation is organized for the following purposes:
