ARTICLES OF INCORPORATION OF T's Pub, Inc



ARTICLE I

The name of the corporation is T's Pub, Inc..

ARTICLE II

Its initial registered office and principal office in the State of Florida is 827 W Bloomingdale in the City of Brandon, County of Hillsborough. The name of the initial registered agent at such address is Terry Welch.

ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV

The total number of shares of capital stock that the corporation shall have authority to issue is 1000, all of which are to be common stock with a par value of \$.01 per share. The total No of voting shares that the Corporation shall have the authority to issue is 1,000, no par value.
