3. PURPOSE. The purpose of this corporation is to engage in the practice of law and to exercise the powers now or hereafter granted to professional service corporations.


4. CAPITAL STOCK. This corporation is authorized to issue one hundred shares of common stock of a par value of \$1.00 a share.


