ARTICLES OF INCORPORATION

OF

JOHN HAWKINS & ASSOCIATES, INC.

I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I

Name and Principal Address

The name of the corporation shall be JOHN HAWKINS & ASSOCIATES, INC., the principal office of the corporation is 1300 Marsh Landing Pkwy, Suite 108, Jacksonville Beach, Florida, 32250-2407, and the mailing address of the corporation shall be P.O. Box 1741, Ponte Vedra Beach, Florida, 32004.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

Purpose

The general nature of the business to be transacted by this corporation is to do all things which are authorized to be done by corporations organized under the laws of the State of Florida.


