The undersigned, incorporator(s) for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following articles of incorporation:

**ARTICLE ONE**

The name of this corporation is LET'S PLAY ATHLETICS, INC.

The corporation is to have perpetual existence.

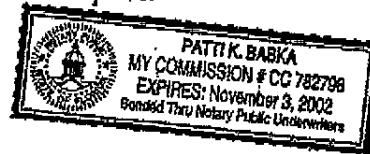


