ARTICLES OF INCORPORATION
OF
SUPERIOR BUILDING MAINTENANCE, INC.

WE, THE UNDERSIGNED natural persons of the age of twenty one years or more, at least two (2) of whom are citizens of the State Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is SUPERIOR BUILDING MAINTENANCE, INC. The principal address for the business will be 4601 SW 42nd Ave, Ft. Lauderdale, Fl 33314.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the corporation is organized are: To conduct a cleaning service company whose activities include the floor care and general cleaning in office buildings and retail stores for any and all persons, firms or corporations interested in securing such services, and for owning and holding property and doing all other matters necessary and incidental to such operations.

ARTICLE FOUR

The aggregate number of shares that the corporation shall have authority to issue is 1,000 shares of common stock, without par value.

ARTICLE FIVE

The corporation will not commence business until it has received, for the issuance of its shares, consideration of the value of ONE THOUSAND DOLLARS (1,000.00), consisting of money, labor done or property actually received, which sum is at least equal to the ten percent (10%) of the total capitalization of said corporation and not less than ONE THOUSAND DOLLARS (1,000.00).




