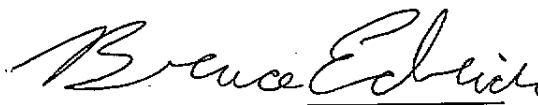
1. The name of the corporation shall be: CitriNet, Inc.
