SECREMENT OF STATE
TEN FORTY SIXTEENTH STREET, INCALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is TEN FORTY SIXTEENTH STREET, INC.

ARTICLE II

The existence of the Corporation shall begin on January 19, 2000.

ARTICLE III

The street address of the principal office of the Corporation is 1040 - 16th Street South, Saint Petersburg, Florida.
