
Re: 2001 Uniform Business Report

Our firm sent in the Uniform Business Report for this year by the original deadline specified. We then received correspondence from your department dated May 22, 2001 (see attached copy) specifying that you had received our annual report along with our payment, but that we needed to provide further information regarding the officers of the corporation. 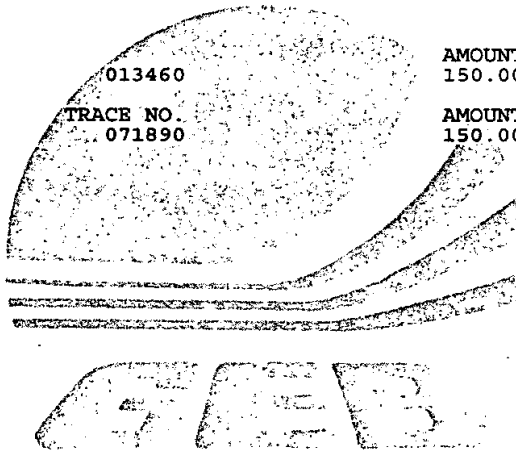
