# ARTICLES OF INCORPORATION OF WILLIAMS BOYS TRUST, INC.

The undersigned subscribers to these Articles of

Incorporation, each a natural person competent to contract
hereby associate themselves together to form a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is WILLIAMS BOYS TRUST, INC.

#### ARTICLE II - NATURE OF BUSINESS
