I have previously sent you the enclosed check and it was returned to us today.

I am enclosing a copy of the envelope in order to show you that we have not paid late our Business Report in purpose.

We previously sent the check and the report VIA "Certified Mail". This was done on February 23rd, 2001 (two months and 1 week before it's due date). I cannot understand why it was returned to us if the address where sent is correct, also, it was not sent by the Post Office until June 18th, 2001 (four full months after it's expedition).

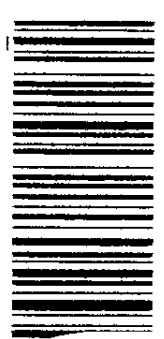
