ARTICLES OF INCORPORATION

OF

SECRETARY OF STATIONAL TALLAHASSEE, FLEET

FIRST. The name of this corporation is Bayswater Commercial, Inc.

SECOND. The address of the initial principal office of the corporation is 3329 N.W. 55th Street, Ft. Lauderdale, FL 33309.

THIRD. The address of the registered office in the State of Florida is 3329 N.W. 55th Street, Ft. Lauderdale, FL 33309. The Registered Agent in charge there of is Tim Davidson.

FOURTH. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

No director of the Corporation shall be liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except for liability (i) for any breach of the director's duty of loyalty to the Corporation or its stockholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under Section 607.0831 of the Florida Business Corporation Act, or (iv) for any transaction from which the director derived an improper personal benefit.
