ARTICLE 1 - NAME

The name of the Corporation is INTERNATIONAL PRODUCE & PERISHABLES ASSOCIATED, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

#### ARTICLE 5 - PRESIDENT

The initial President of the corporation shall be OSVALD SELENT , whose address shall be the same as the principal office of the corporation.
