ARTICLES OF INCORPORATION

The undersigned hereby associate for the purposes of forming a Florida Professional Service Corporation for the purposes of carrying on the undersigned's profession and transacting business in the corporate form in accordance with the laws of the State of Florida and the Articles hereinafter set forth.

ARTICLE I: NAME OF PROFESSIONAL SERVICE CORPORATION

ARTICLE II: PURPOSE OF PROFESSIONAL SERVICE CORPORATION

ARTICLE XII: ADDITIONAL CORPORATE POWERS

(d) To enter into for the benefit of its employees, one or more of the following:

- (i) A pension plan;
- (ii) A profit-sharing plan;
- (iii) A stock bonus plan;
- (iv) A restricted stock option plan;
- (v) A medical reimbursement plan
- (vi) Other retirement or incentive compensation plan.

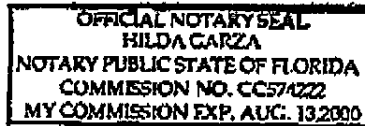
