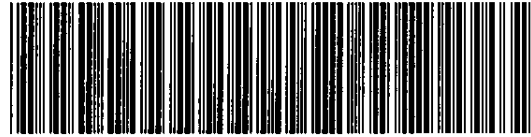

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be SC SERVICES & ASSOCIATES, INC.  
(hereinafter referred to as the "Corporation").

**ARTICLE II - ADOPTION AND TEXT OF AMENDMENTS**

The sole Director of the Corporation approved a resolution amending Article I of the Articles of Incorporation by Written Consent dated August **26**, 2011, executed in accordance with the provisions of Section 607.0821 of the Florida Statutes, the shareholders of the Corporation approved the resolution amending Article I of the Articles of Incorporation by Written Consent dated effective August **26**, 2011, executed in accordance with the provisions of Section 607.0704 of the Florida Statutes, and the number of votes cast for the amendment to the Articles of Incorporation was sufficient for approval. The following is a true and correct copy of the resolution amending Article I of the Articles of Incorporation:

RESOLVED, that Article I of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:

**"ARTICLE I - NAME**

The name of the Corporation shall be DEEP SOUTH  
RECOVERY, INC."

**ARTICLE III - EFFECTIVE DATE OF AMENDMENT**

The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein shall be as of September 1, 2011, which date is not more than ninety (90) days after the filing of these Articles of Amendment to the Articles of Incorporation with the Secretary of State of the State of Florida.
