**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is HARI HARI, INC., and the principal address and principal place of business is 4761 COCONUT PALM CIRCLE NORTHEAST, ST. PETERSBURG, FLORIDA 33703.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o PATEL & O'CONNOR, P.A., 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Patrick M. O'Connor, Esquire.

**ARTICLE III - PURPOSE**
