The Uniform Business Report form and Annual Report Notices mailed by the State were not received by the above referenced corporation and were a report was not filed for 2001. During 2001, one of the Officers of the Corporation who was also the Registered Agent, left the company in a hostile and predictably vengeful manner. As such, it is surmised that he either received and never forwarded the UBR to the remaining officer of the corporation or perhaps returned the same to the Division of Corporations unopened. Either way, the remaining officer of the corporation, Mandy Waite, was never aware of this and never received a UBR form or the Notices from the State and an Administrative Dissolution resulted.

We are, therefore, respectfully requesting your review and approval for the one time waiver of the reinstatement penalty fee for this corporation. Pursuant to instructions from your office, I have included herewith the Application for Reinstatement Form and a check for \$308.75. This will cover the reinstatement fee for 2001, the 2002 fee which is now due, plus \$8.75 for a Certificate of Status, which should bring this corporation current.
