**ARTICLES OF INCORPORATION
OF
ASSEMBLING FURNITURE FOR COMPUTERS, INC.
I, THE UNDERSIGNED, BEING OF LEGAL AGE AND A NATURAL PERSON, DO
HEREBY SUBSCRIBE TO, ACKNOWLEDGE AND FILE THE FOLLOWING ARTICLES OF
INCORPORATION FOR THE PURPOSE OF CREATING A CORPORATION UNDER THE LAWS OF
THE STATE OF FLORIDA.**

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE ASSEMBLING FURNITURE FOR COMPUTERS, INC.. AND THE INITIAL ADDRESS OF THIS CORPORATION SHALL BE 80 NW 116 PLACE #2, MIAMI, FL. 33172.


