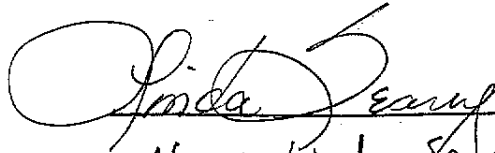
CORPORATE PURPOSE

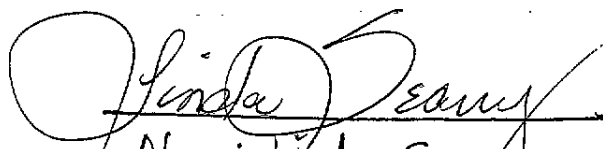
