**ARTICLES OF INCORPORATION  
OF

**ARTICLE I – NAME**

The name of this corporation is PORTOFOLIO, INC.

**ARTICLE II – DURATION**

This corporation shall exist perpetually, commencing at the date of filing.

**ARTICLE III – PURPOSE**

This corporation is organized for the purpose of transacting any lawful business.

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

**ARTICLE V – PREEMPTIVE RIGHTS**

**ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VII – INITIAL BOARD OF DIRECTORS**

The price, terms and time of which such shares may be offered and sold shall be further specified in the By-Laws of this corporation.

**ARTICLE XIV – TAX ARTICLE**

It is the intention of this charter that the directors shall sell the capitol stock of this corporation in accordance with the intent of Section 1242 – 1244, inclusive, of the Internal Revenue Code.
