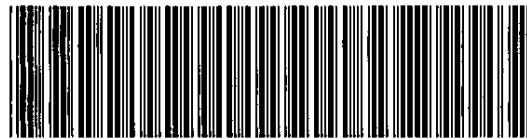

“ARTICLE I.


The name of the Corporation is PONTE VEDRA INSURANCE, INC.”

4. The foregoing amendment was approved by Written Consent to Resolutions by the Incorporator of the Corporation.


