ARTICLES OF INCORPORATION

BIZWORKS, INC.

ARTICLE I. NAME

The name of this corporation shall be Bizworks, Inc.

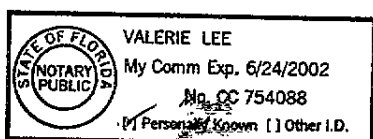


