



*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

ARTICLE I.            NAME

The name of this corporation shall be: **National Landscape & Tractor Service, Inc.**



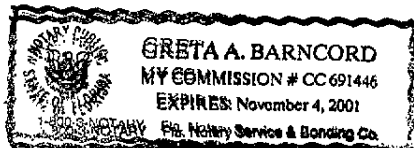
