**ARTICLES OF INCORPORATION  
OF  
MILLENNIUM GOLF VENTURES INCORPORATED**

The undersigned, an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name for the corporation (hereinafter called the "Corporation") Is Millennium Golf Ventures Incorporated.

**SECOND:** The number of shares which the Corporation is authorized to issue is ten thousand (10,000) shares common stock, par value one dollar (\$1.00) per share.

**THIRD:** The street address of the initial registered office of the Corporation is 12500 Stage Coach Lane Hudson, Florida 34667

The name of the initial registered agent of the Corporation is Christopher R. Karamitsos.

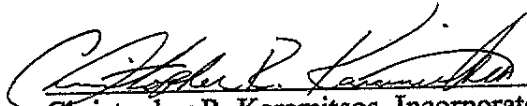

**SEVENTH:** The duration of the Corporation shall be perpetual.

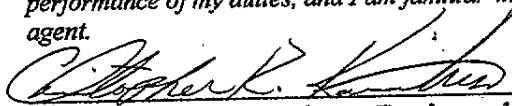
