## AMENDMENT TO THE ARTICLES OF INCORPORATION OF

ίOdyssey, Inc.

The undersigned director, having been authorized at a meeting of the shareholders and directors and for the purpose of amending the Articles of Incorporation of iOdyssey, Inc., hereby adopts the following amendments to the Articles of Incorporation.

#### ARTICLE III

Article III originally read:

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any on time is ten million shares. All such shares shall be of a single class and series, with a \$.0001 par value.
