I, the undersigned, for the purposes of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation.

> ARTICLE I NAME

Any Incorporator or Stockholder present at any meeting, either in person or by proxy, and any Directors present in person at any meeting of the Board of Directors shall conclusively be deemed to have received proper notice of such meeting unless he shall make objection at such meeting to any defect or insufficiency of notice.
- F. The Corporation shall indemnify all Officers and Directors of the Corporation to the fullest extent permitted by law.
- G. No contract or other transaction between this Corporation and any other Corporation shall be effected or invalidated by the fact that any one or more of the
