ARTICLE I - NAME

The name of this corporation is Java Jim's, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE IX – INDEMNIFICATION


The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.




