ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is J & C Dock Rescue, Inc., a Florida corporation and the address of the principal office is 884 Belville Blvd., Naples, Florida 34104.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV

The corporation shall have authority to issue Ten Thousand (10,000) shares, all of one class, One (\$1.00) Dollar par value.

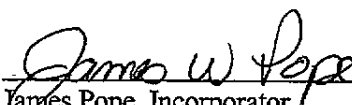

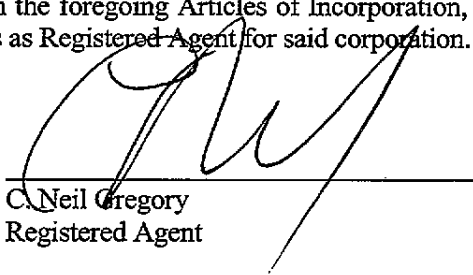
