### ARTICLES OF INCORPORATION OF R. CHACON DRYWALL, INC.

#### **ARTICLE I - NAME**

The name of this corporation shall be R. Chacon Drywall, Inc..

#### **ARTICLE II - PURPOSE**

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

#### **ARTICLE III - CAPITAL STOCK**

The maximum number of shares of stock this corporation shall be authorized to have outstanding at any one time shall be **[seven thousand five hundred (7,500)]** shares of common stock of the par value of one dollar (\$1.00) per share, upon which there are no preemptive rights except to the extent specified by the By-Laws. #### **ARTICLE V - TERM OF EXISTENCE**

This corporation will exist perpetually.

#### **ARTICLE VI - PRINCIPAL OFFICE**
