ARTICLES OF INCORPORATION

Article I - Name

The name of this corporation is **TAKOMACHEK, INC., a Florida corporation.** The mailing address for the corporation is 5101 N.W. 65th Lane, Gainesville, FL 32653.

Article II - Duration

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue ten thousand (10,000) shares of 01/100ths Dollars (\$.01) par value common stock, which shall be designated "Common Shares".
