The name of this corporation is NETTLE CREEK INTERIORS, INC.

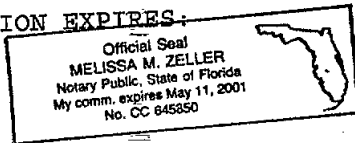
