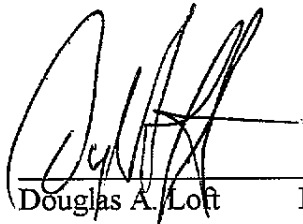
ARTICLE IX. BYLAWS

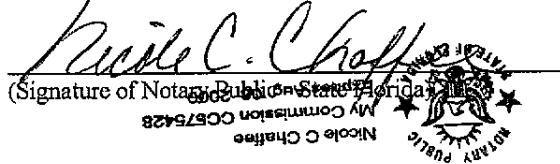

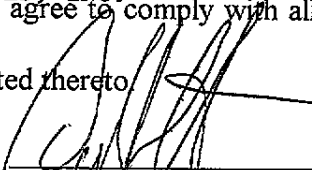
