ARTICLE I-Name

The name of this corporation is Value, Corp. of Highlands County

ARTICLE II- Principal Office

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.
