ARTICLES OF INCORPORATION
OF
DESIGN TILE CONSULTANTS, INC.

I, the undersigned, make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purposes of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

NAME AND ADDRESS

The name of the corporation shall be: DESIGN TILE CONSULTANTS, INC., and the principal office and mailing address is: 2301 Eaton Court, Safety Harbor, Florida 34695.

ARTICLE II

CAPITAL STOCK

The total number of shares of capital stock authorized to be used by the corporation shall be seven thousand (7,000) shares all of one class having a par value of One Dollar (\$1.00) per share. Each of said shares of stock shall be identical with each other in every respect and the holders of the stock shall be entitled to one vote for each share on all matters on which stockholders have the right to vote.

ARTICLE III

INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors shall be two and the names and addresses of the persons who are to serve as the members thereof are as follows:

ARTICLE VI

PREEMPTIVE RIGHTS

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the

ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. The right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
