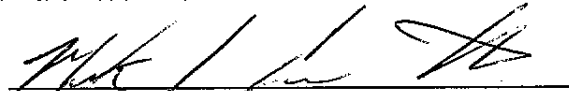

Indemnification

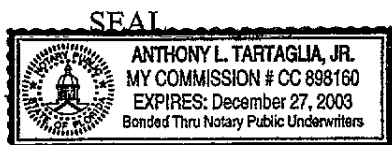
