ARTICLES OF INCORPORATION
OF
DOUG LOOSE CONSULTING SERVICES, INC.

ARTICLE I - NAME

The name of this corporation shall be DOUG LOOSE CONSULTING SERVICES, INC.

ARTICLE II - DURATION

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

A. This corporation is organized for the purpose of transacting any or all lawful business. Initially, this corporation shall engage in the business of providing consulting services.

B. This corporation is organized to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

ARTICLE IV - CAPITAL STOCK

The capital stock of this corporation shall consist of one thousand shares of common stock having a nominal or par value of Five Dollars (\$5.00) per share. The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States of America, or property, labor or services at a just valuation to be fixed by the Directors.

ARTICLE V - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he

already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office and the principal address of this corporation is 4712 Spinnaker Drive, Bradenton, Florida 34208, and the name of the initial registered agent of this corporation is DOUGLAS JAMES LOOSE, SR. The signature of DOUGLAS JAMES LOOSE, SR., hereinbelow signifies his acceptance of his designation as registered agent. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one. The names and addresses of the initial Board of Directors of this corporation are:

ARTICLE X - BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be

vested in the Board of Directors.

ARTICLE XI - INDEMNIFICATION

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

ARTICLE XII - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stockholders entitled to vote thereon, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XIII - BEGIN EXISTENCE

Pursuant to the provisions of Article 607.0203, Florida Statutes, this corporation shall begin existence when these Articles of Incorporation are filed.

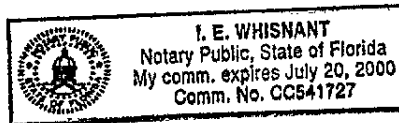

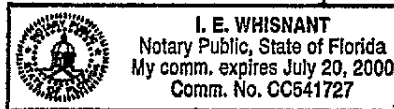
