ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TEKKSPORTS, INC., and the principal address and principal place of business is 74 BAYWOODS DRIVE, SAFETY HARBOR, FLORIDA 34695-5401.

ARTICLE II - REGISTERED OFFICE AND AGENT
