ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Millenium Air & Heating Inc. and 11412 Aries Drive, Orlando, Florida 32837, respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
