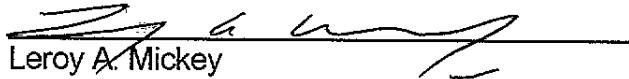
#### **ARTICLE VIII - BYLAWS**

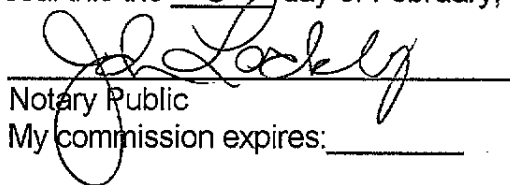
