The undersigned, for the purpose of forming a Corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME:

The name of this Corporation is ADMIRALTY MARINE SURVEYORS, INC. The principal place of business of this corporation shall be:



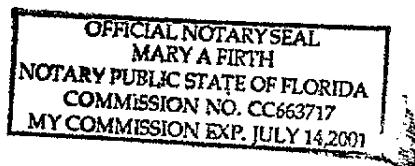
