

**ARTICLES OF INCORPORATION**

**OF**

**LOBSTER DEPOT, INC.**

**ARTICLE I - NAME**

The name of the corporation is **LOBSTER DEPOT, INC.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved according to law.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which this corporation is authorized to issue is 5,000 shares of common stock having a par value of \$1.00 each, and such shall be designated "common shares".

**ARTICLE V - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale (by this corporation) for cash or property of any new stock of this corporation of the same kind, class or series as that which she already holds, shall have the right to purchase their pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price

per share at which it is offered to others (based on cash value or fair market value of property involved in the sale).

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1101 South Dixie Highway West, Pompano Beach, Florida 33060 and the name of the initial registered agent of this corporation at that address is MONICA LaFLEUR. ARTICLE VII - INITIAL BOARD OF DIRECTORS
